



CONTEST OFFICIAL RULES 2019

NO PURCHASE NECESSARY. Void where prohibited. A purchase will not increase the chances of winning. **The Drive Safe Los Angeles Contest** (“Contest”) starts on **August 20th, 2019**, and ends on **October 25th, 2019**. All entries must be received by midnight, October 25th, 2019.

How to Enter: To enter the Contest, you must be between the ages of 13 and 19 and a legal resident registered in a California public, private or home school and create a written script for a 30-second public service announcement (“PSA”) on the Dangers of Drugged Driving.

No videos will be accepted. All entries must be clearly written in blue or black ink. Ineligible entries will be disqualified.

Completed entries must be mailed by the deadline date to Drive Safe Los Angeles Contest, c/o The National Road Safety Foundation, Inc., 18 East 50th Street, New York, NY 10022. All entries must include the PSA script, your name, address and phone and/or email contact information, as well as the name and address of the school you attend. Entries must be signed by a parent or legal guardian, with parent/legal guardian’s contact information (phone and/or email address). Entries may only be submitted by mail (not by email).

Each entry must be in keeping with The National Road Safety Foundation’s (“NRSF”) images and may not be offensive or inappropriate, as determined by NRSF and the Los Angeles Auto Show at their sole discretion. Furthermore, an entry may not defame or invade publicity rights or the privacy rights of any person, living or deceased, or otherwise infringe upon any person’s personal or property rights or any other third-party rights.

Eligibility: The Contest is open only to students who are currently ages 13 – 19 and reside in California and are legal residents of the United States, attend a public, accredited private school, or home school (“Schools”) in compliance with the laws of California. Employees of NRSF and the Los Angeles Auto Show and members of their immediate families living in the same household, their parents, subsidiaries, affiliates, and their advertising, promotion, and production agencies, are not eligible to enter.

The entries will be provided to both NRSF and Los Angeles Auto Show, and will be subject to their respective privacy policies, which can be found, respectively, at the following link: <http://www.nrsf.org/terms>

NRSF and the Los Angeles Auto Show are not responsible for late, lost, stolen, inaccurate, garbled, damaged, illegible, undelivered, delayed, misdirected, or postage-due entries or mail, or for any computer, network, technical, typographical, human, or other error, problem, or malfunction related to or in connection with the Contest.

All personal information collected from entrants, parents/ guardians and teachers will be retained in accordance with NRSF’s records-retention policies for the Contest (all entries will be kept for one year following selection of the winner; all winning entries will be kept for up to three years). By submitting an entry in this Contest, the entrant understands and consents to the collection, maintenance, processing, and transfer of his or her information in and to the United States and to NRSF. The entrant acknowledges and agrees that such information may be available to United States authorities or otherwise accessed in accordance with United States federal or applicable state law.

Entries: By submitting an entry, each entrant agrees NRSF shall own the entry submitted (including all rights embodied therein in winning entries) and any derivative works made therefrom and that it and its designees may use, edit, publish, adapt, modify, or dispose of any entry and elements embodied therein online, in print, film, television, or in any other media now or hereafter known for advertising, promotional, or other purposes throughout the world, in perpetuity, without additional compensation or notification to, or permission of the entrant, except as prohibited by law.

Judging Criteria: Entries will be judged on the following criteria:

1. Originality and creativity (35 points) (Is the PSA unique and creative?)
2. PSA concept (35 points) (Does the PSA clearly and accurately address the contest topic? Are the message and concept effective?)
3. Clarity of message (30 points) (Is the idea communicated clearly? Is the PSA well organized?)

Prizes: One Grand Prize will be awarded. The Grand Prize will win \$2,000, and the NRSF production company will come to the winner's school and work with the winner to professionally produce the winning concept.

One runner-up will receive \$1,000.

If they entry forms of the winner and runner-up are signed by a teacher, the teachers will each receive a \$100 gift card.

Selection of Winners: Entries submitted will be judged by NRSF and the Los Angeles Auto Show. The winner will be notified on or around one week after the deadline date. Each entrant agrees to be bound by the Official Rules, and the decisions of the judges are final in all matters relating to this Contest.

By entering and/or accepting a prize, each entrant and/or winner hereby releases and holds harmless NRSF and Los Angeles Auto Show, their respective affiliates, subsidiaries, advertising and promotion agencies, and all others associated with the development and execution of this Contest (including prize suppliers), and the respective officers, directors, shareholders, agents, and employees of the foregoing from any and all claims, demands, losses, promises, causes of action, and liabilities arising out of the preparation for or participation in this Contest, or any use or misuse of any prize (or any portion thereof) awarded hereunder, including any travel or activity related thereto.

The winner will provide any and all reasonable assistance to NRSF in connection with the filming of the PSA.

The winner and his or her PSA will also be featured at the Los Angeles Auto Show. In addition, the winner, or image of winner, may also be used for local and national publicity, and will be featured on the NRSF websites and newsletters. This prize is contingent upon the Grand Prize winner providing reasonable assistance to NRSF in terms of any necessary information to include in news releases and other press material.

No cash substitutions for prizes. In the event of prize unavailability, a prize of equal or greater value will be awarded as determined by the Sponsor's sole discretion. Prizes are nontransferable. All federal, state, and local taxes, if any, are the sole responsibility of the Winners. Void where restricted or prohibited.

General: By entering, each entrant agrees to abide by these Official Rules, warrants and represents that their entry is their original work. Further, each entrant grants to NRSF and the Los Angeles Auto Show the right to use names, information provided, images, and likeness in any media now or hereafter known for advertising, promotion, and/or other purposes throughout the world without additional compensation or notification to, or permission of, the entrant, except as prohibited. If NRSF discovers at any time, during or after the Contest, that an entry contained infringing material, the entrant that submitted the entry will be immediately disqualified.

In the event the Contest is compromised by non-authorized human intervention, virus, bugs, or other causes beyond the control of the Sponsor that corrupt or impair the administration, security, fairness, or proper play of the Contest, the Sponsor reserves the right in its sole discretion to modify, suspend, or terminate the Contest or any portion thereof and/or terminate the participation of any participant whose conduct potentially compromises the Contest, and is at its sole discretion to award the prizes from among all eligible non-suspect entries received prior to termination using the judging procedures outlined above. In the event the named winner cannot accept, participate or at the discretion of NRSF be disqualified, the runner up will be named as winner of the contest.
